LEVELLING UP FUND

Nicola Hopkins reported that a bid application in respect of the Government's Levelling Up Fund had been submitted with letters of support from Lancashire County Council and Nigel Evans MP. The Group were reminded that the fund is aimed at supporting town centre and high street regeneration, local transport projects, and cultural and heritage assets.

Nicola went on to say that the time scales of a government announcement on the successful bids is not yet known.
